China was identified as a "go deep" market for Cigna in 2012 and Howard moved to Shanghai and was seconded to a JV with China Merchants Bank to drive Health. Whilst there, Howard became regional CEO for ME&AP. After 3 years Howard moved to Dubai and in 2015 became CEO for EMEA and Government Solutions until 2020.

Prior to Vielife and Cigna, Howard began his career as a qualified Chartered Accountant, built a Management Consultant practice and then followed an entrepreneurial path in the FMCG marketing agency sector.
